## SEEDING CRITERIA

### Seeding for the 2A Sub Regional Tournament will be based on:

1. Head to Head - Current Year. If tied, the last match decides seed unless decided by injury default.
2. State Placer - Anytime
3. State Participant - Anytime
4. Overall record -Excluding forfeits
  - If both participants have wrestled more than 20 matches, comparison will be based on win percentage.
5. Common Opponents - If wrestlers are tied after the 4 initial seeding criteria, common opponents will apply.
6. Random Draw - If wrestlers are tied after the 5 initial seeding criteria, they will be placed in a random draw for the current seed.
  - After an athlete is "randomly drawn" for the current seed, we will move to the next seed and start at the beginning criteria.
  - Example: Wrestlers A, B, and C are all tied for the #1 seed. Random draw occurs, and Wrestler A is randomly drawn for seed 1. Wrestlers B and C will now be using criteria, from the beginning (1.) to select #2 seed.

### Pigtail Criteria

- Pigtail is not a part of tournament. You are wrestling to get into the 16 person bracket
- If wrestler loses pigtail match, they are out (1 and done).
- Pigtail match does not score team points for tournament
- Pigtail bracket placement after seeds is random to 16. Wrestlers left will be placed against #16-#13 seeds in that order.

## TOURNAMENT POINTS

The top six (6) placers in each weight class earn points at the following ratio:

FIRST PLACE.....16 points	FOURTH PLACE.....7 points
SECOND PLACE.....12 points	FIFTH PLACE.....5 points
THIRD PLACE.....9 points	SIXTH PLACE.....3 points

## WEIGH-IN

- National Federation Wrestling Rules weigh-in procedures will be used at all WIAA Regional Tournaments. · Electronic scales will be used for weigh-ins and should expedite the process.
- Officials will be available at the weigh-ins for skin checks. Officials will be at each scale. We will run at least two scales during weigh-in.
- 2lb weight allowance will be in place for this competition (120lb = 122lb)

## PROTESTS

Any protest occurring at the tournament will be presented to the Tournament Director. He/She in turn will confer with the tournament committee. Decisions of the committee are final.

## CONCESSIONS

Concessions will be available.

## CHEERLEADERS

Up to eight cheerleaders in uniform and their advisor will be admitted free. Only four cheerleaders will be allowed at the side during a match.

## LOCKER ROOMS

Locker rooms will be provided. Individuals will need to provide their own towels and are expected to treat the facilities with care.

## W.I.A.A. TOURNAMENT RULES

W.I.A.A. tournament rules will apply. (I.e. Sportsmanship, signs, noisemakers, floor restrictions, coaches in the corner and admissions.)

## FLOOR RESTRICTIONS

There will be no reserved seating sections. Space will be limited when we are wrestling on four mats. A coach, assistant coach, trainer, or manager, not a wrestler, will be permitted to sit in the chairs mat side during the matches. The limit is two coaches per school at a mat. We insist they remain seated in their chair during the course of the match and not run onto the mat for coaching or any other purpose, unless there is an injury. No one other than official staff will be allowed on the floor. Photographers and Video Cameras will not be allowed on the floor.

## INJURED WRESTLERS

A wrestler removed from participation in a tournament match due to an injury, shall not be allowed to continue until authorized by the medical authority that made the original decision at that tournament, or his/her designee. Decisions by the medical authority are final.
